Application for Accreditation Reviewer access through the Reviewer Portal


This document details how CODA application reviewers (CODA site visitors) login and access program application submissions through the reviewer portal.

Login

In order to login to the portal, users should use the following URL:

https://codaportal.ada.org

The following login screen will appear. Enter the **user id** of the application reviewer, assigned as a web user, along with the **password** assigned. Then click the "Log In" button.



Upon successful login, the user will be redirected to the reviewer portal. A list of assigned application reviews will display. In order to access a submission, **click on the "Review" link under the "Action" header**.

To review any of the documents submitted by the program, **simply click on the document links in the left hand side of the page**. Depending on your browser, the file will either download or open up in a separate browser window.

If you download materials to your computer, you must ensure the materials are held in a specific designated CODA folder and securely disposed of following your assignment. You may download materials if you are using an encrypted computer, per CODA requirements.

Once materials are downloaded to the designated CODA folder on your computer, you must immediately and securely delete the items from your computer's "Downloads" folder.

CODA Protocol for Secure Disposal of Materials Following Completion of Application Review Assignment:

To securely dispose of materials, you are requested to personally do the following:

- <u>"Securely Delete" files from your computer:</u>
 - To securely delete a file if you are using Windows:
 - Click once on the file to highlight it but not open it
 - Click "shift" and "delete" to permanently delete the file
 - Check your Recycle Bin to ensure the file is permanently deleted. If it appears in the Recycle Bin, delete it again
 - To securely delete a file if you are using a Mac:
 - Delete the file
 - Go to your Mac's Finder menu (upper left-hand side of your screen)
 - Choose "Secure Empty Trash..."
 - Deleted files from the "Downloads" folder of your computer and then check your Recycle Bin and delete the files again.

 - o Click "shift" and "delete" to permanently delete the attachment
 - Check your Deleted Items Folder to ensure the file is permanently deleted. If it appears in the Deleted Items Folder, delete it again
