The meeting of the Review Committee on Dental Hygiene Education (DH RC) was held on January 11-12, 2022 via a virtual meeting. The DH RC report is found in **Appendix 11**.

*Informational Report on Dental Hygiene Programs Annual Survey Curriculum Data:* There was no discussion on this report.

**Commission Action:** This report is informational in nature and no action was taken.

*Consideration of Proposed Revisions to the Accreditation Standards for Dental Hygiene Education Programs Related to Standards 2-14 and 3-7:* The Commission considered the DH RC's report. The Dental Hygiene Commissioner identified a concern related to the proposed revision to Standard 3-6, namely that the revision would exempt all full-time and part-time dental hygiene faculty appointed prior to January 1, 2023 from the degree requirement. As such, the Dental Hygiene Commissioner requested that the proposed revisions be returned to the Dental Hygiene Review Committee for further consideration at the Summer 2022 meeting. Through discussion, the Commission noted that there is a significant faculty shortage and that this type of standard does not exist in the predoctoral dental education Standards document. Following discussion, the Commission referred this matter back to the DH RC.

**Commission Action:** The Commission on Dental Accreditation directs that the Dental Hygiene Review Committee further consider the proposed revisions to Standards 2-14 and 3-6 of the Accreditation Standards for Dental Hygiene Education Programs found in **Appendix 11**.

*New Business: Request for Addition of a Dental Hygiene Educator on the Review Committee on Dental Hygiene Education:* The Commission learned that the DH RC would benefit from an additional dental hygiene educator on the Review Committee to help address the workload of the Committee. Additionally, the Commission noted the request of the DH RC to extend the Review Committee meeting by one-half day, as needed, to ensure appropriate time to address the Committee's workload. The Commission discussed its policies related to the addition of a Review Committee member, noting that a non-content expert should be added to the Review Committee when a content expert is added to retain a balance on the Committee. The Commission also noted the financial impact related to this request and the addition of two (2) members on the DH RC, one (1) content expert and one (1) non-content participant. Following discussion, the Commission modified and acted upon the DH RC's recommendations.

**Commission Action:** The Commission on Dental Accreditation directs the appointment of one (1) dental hygiene educator, and one (1) non-content participant, through self-nomination of qualified nominees, to the Review Committee on Dental Hygiene Education, effective Winter 2023.



The Commission on Dental Accreditation further directs the Review Committee on Dental Hygiene Education meetings be extended by one-half day, as needed, based upon the Committee's workload needs, effective immediately.

*New Business: Consideration of the Commission on Dental Accreditation Biosketch for Allied Dental Education Programs:* The Commission considered the recommendation of the DH RC to establish an Ad Hoc Committee to review the Allied Biosketch template to ensure clarity and submission of current, complete and accurate information by programs.

**Commission Action:** The Commission on Dental Accreditation directs the appointment of an Ad Hoc Committee of dental hygiene and dental assisting Review Committee members to review the Allied Biosketch template, with a report to the Commission in Summer 2022.

*Report on Dental Public Health Programs Annual Survey Curriculum Section:* The Commission considered the report of the DPH RC related to its Annual Survey Curriculum Section.

**Commission Action:** The Commission on Dental Accreditation directs the Dental Public Health Annual Survey Curriculum Section for dental public health programs (**Appendix 13**) be retained with no changes for use in Fall 2022.

*Informational Report on the Conduct of a Validity and Reliability Study for the Accreditation Standards for Advanced Dental Education Programs in Dental Public Health:* There was no discussion on this report.

**Commission Action:** This report is informational in nature and no action was taken.



*New Business: Consideration of Proposed Revision to Standard 2-4 of the Accreditation Standards for Advanced Dental Education Programs in Dental Public Health related Use of the Term “Calibration”:* The Commission considered the DPH RC’s recommendation to revise Standard 2-4 of the Accreditation Standards for dental public health. The Commission noted that the DPH RC also recommended that all Review Committees of the Commission review the Standards within their purview to consider replacing the word “calibration” with the word “training” in the context of Standards related to faculty calibration/training, as appropriate.

Regarding the DPH RC’s recommendation that all Standards be reviewed and potentially revised, several Commissioners noted that training and calibration are not the same. There is wide confusion related to calibration within dental education; there is both qualitative and quantitative calibration, and this concept should be considered. Calibration is specific to the defined standards and is intended to ensure intra- and inter-reviewer reliability. It was further noted that “training” assures delivery of the content, while “calibration” ensures a level of consistency. Several Commissioners believed that the revision would be a step backwards with regard to CODA’s expectation for faculty calibration. However, it was noted that within dental public health education, students/residents are taught the concept of scientific calibration techniques, which may differ from how faculty calibration is viewed and may cause confusion and concern among the dental public health education community.

Following lengthy discussion, the Commission directed further modification of the proposed language for Dental Public Health Standard 2-4, to clarify that “training” is “to a standard.” The final proposed revision is as follows (Underline indicated addition; Strikethrough indicates deletion):

Dental Public Health Standard 2-4:

All faculty, including those at major and minor educational activity sites, must be ~~calibrated~~trained to a standard to ensure consistency in training and evaluation of students/residents that supports the goals and objectives of the program.

*Intent: Faculty ~~ealibration~~training may consist of outcomes based on the use of evaluation forms, tools, metrics and/or minutes of faculty ~~ealibration~~ training sessions showing consistency across all sites.*

In a separate action, the Commission defeated the DPH RC’s recommendation that all Review Committees of the Commission consider replacing “calibration” with “training” as it relates to faculty calibration Standards.

**Commission Action:** The Commission on Dental Accreditation directs circulation of the proposed revisions to Standard 2-4 of the Accreditation Standards for Advanced Dental Education Programs in Dental Public Health, noted above, to the communities of interest for review and comment, with Hearings conducted in conjunction with the March 2022 American Dental Education Association (ADEA) Annual Session and the October 2022



American Dental Association (ADA) Annual Meeting, with comments reviewed at the Commission's Winter 2023 meetings.

**Commission Action:** The Commission on Dental Accreditation directs the Oral and Maxillofacial Surgery Annual Survey Curriculum Section for oral and maxillofacial surgery residency programs (**Appendix 15**) be retained with no changes for use in Fall 2022.

The Commission on Dental Accreditation further directs the Oral and Maxillofacial Surgery Annual Survey Curriculum Section for oral and maxillofacial surgery fellowship programs (**Appendix 16**) be retained with no changes for use in Fall 2022.

- Adoption of a 2% increase in annual fees for all disciplines in 2023; \$8,380 for predoctoral dental education programs, \$2,100 for dental assisting, dental hygiene, dental therapy, and advanced dental education programs, and \$1,490 for dental laboratory technology programs.
- Affirmation that during the year a program is due for a regular accreditation site visit, the annual fee will be doubled.
- Maintaining the application fees of \$67,400 for predoctoral dental education programs and \$16,850 for allied and advanced education programs.

*International Fees (For CODA Accreditation Process):* The Commission considered international fees and took the following actions.

**Commission Action:** The Commission on Dental Accreditation directs:

- Maintaining the international predoctoral dental education application fee of \$76,660 in 2023.
- Adopting a 2% increase in the international predoctoral dental education annual accreditation fee of \$19,670 in 2023.
- Affirming that in 2023 international predoctoral dental education programs pay all site visit expenses (actual expenses) for all site visits during the application and regular site visit schedule.
- Affirming that in 2023 international predoctoral dental education programs pay an administrative fee of 25% of the total site visit cost for coordination of each site visit.
- Maintaining the International Consulting Fee (outside of PACV process) of \$5,000.
- Affirming that all international fees must be paid in U.S. Dollars.

*Other Accreditation Fees:* The Commission considered other fees and acted upon the Finance Committee's recommendations.

**Commission Action:** The Commission on Dental Accreditation directs:

- Maintaining the Special Focused Site Visit Administrative Fee of \$5,000.
- Maintaining the CODA Fee for Non-Compliance with CODA Policy on Privacy and Data Security (HIPAA) of \$4,000 per program per submission.
- Maintaining the Email/Contact Distribution List Fee of a \$200 minimum.
- Assessing the CODA Administrative Fund fee of \$25 per program in 2023.

**Invoicing Process for Special Focused Site Visits**

In advance of the special focused site visit, the program must remit payment for the Administrative Fee (\$5,000 ~~in 2020 and 2021~~) plus \$1,500 per site visitor/staff attending visits up to two (2) days in length. Site visits that are three (3) or more days will be billed an additional \$500 per site visitor/staff for each additional day; further, if additional airfare or transportation expenses are incurred, these will be assessed to the program. Failure to submit the special focused site visit fee in advance of the visit may result in a delay of the visit and additional rescheduling cost to the program, and may impact the program's accreditation status. See Program Fee Policy.

**Commission Action:** The Commission on Dental Accreditation directs revision to the policy on Invoicing Process for Special Focused Site Visits, within the Evaluation and Operational Policies and Procedures, effective immediately.

**Commission Action:** The Commission on Dental Accreditation continues to monitor the adequate number of volunteers, including discipline-specific volunteers, to serve on all levels of the Commission including review committees and the Board of Commissioners and consider modifications, as necessary, in the future.



*Consideration of Proposed Revisions to Miscellaneous Policies:* The Commission reviewed the report of the Standing Committee and concurred with its recommendations related to revision of Commission policies and procedures found in the Evaluation and Operational Policies and Procedures (EOPP) manual.

**Commission Action:** The Commission on Dental Accreditation adopts and implements immediately the proposed revisions to policies found in **Appendix 31**, including the revision of policies in the Commission's EOPP and in all appropriate Commission documents.

The Commission on Dental Accreditation directs staff to further review and propose changes to the Criteria for Granting Accreditation for consideration at the Summer 2022 meetings of the Standing Committee on Documentation and Policy and the Commission.

The Commission on Dental Accreditation directs staff to further review and propose changes to the Policy on Interruption of Education for consideration at the Summer 2022 meetings of the Standing Committee on Documentation and Policy and the Commission.

The Commission on Dental Accreditation further directs the Review Committees on Postdoctoral General Dentistry, Dental Anesthesiology, Oral Medicine and Orofacial Pain to review the Policy on Enrollment Increases in Advanced Dental Education Programs and consider the implementation of authorized enrollment for programs in these disciplines, for consideration at the Winter 2023 meeting of the Standing Committee on Documentation and Policy and the Commission.

The Commission on Dental Accreditation further directs the deadlines for submitting reports to CODA found in **Appendix 31** be revised to a new deadline of May 1 and November 1, with immediate implementation, and that the Commission's EOPP and all appropriate Commission documents be updated, as applicable.

**Report of the Standing Committee on Communication and Technology:** The report of the Standing Committee on Communication and Technology can be found in **Appendix 32**. While the report was informational, a summary of activity was provided by the Chair of the Standing Committee on Communication and Technology.

*CODA Website Analytics:* There was no discussion on this report.

**Report of the Ad Hoc Committee on Alternative Site Visit Methods:** The Commission considered the report and recommendations of the Ad Hoc Committee on Alternative Site Visit Methods (**Appendix 33**). The Commission discussed the approach and recommendations related to the sites that require an on-site follow-up within a “reasonable” amount of time. It was noted that the United States Department of Education’s language allowed flexibility to the accrediting agency. The Commission noted that virtual visits began in March 2021 and will require an on-site follow-up. There are approximately 80 programs that will require a follow-up visit, including some “special focused” visits that are facilitated like a “regular” site visit.

**Commission Action:** The Commission on Dental Accreditation adopts the proposed revisions to the Policy on Temporary Use of Alternative Site Visit Methods (**Appendix 33**) to include protocols for in-person follow-up site visits following virtual site visits, with immediate implementation.

The Commission on Dental Accreditation further directs staff to initiate the follow-up on-site visit planning, and to develop and disseminate to programs and CODA site visitors a template Site Visit Schedule and template Site Visitor Evaluation Report specific to the on-site visit process following a virtual site visit.

The Commission on Dental Accreditation further directs staff to gather data to facilitate the Ad Hoc Committee on Alternative Site Visit Method’s study of alternative site visit methods to identify whether any changes in processes or procedures for the conduct of site visits using alternative methods could be implemented long-term.

**Report of the Ad Hoc Committee on Volunteerism:** The Commission considered the report and recommendations of the Ad Hoc Committee on Alternative Site Visit Methods (**Appendix 34**).

**Commission Action:** The Commission on Dental Accreditation directs the Standing Committee on Finance to review the Commission’s funding model to determine the impact of a stipend and honorarium on the Commission’s operational budget, with a report to the Commission in Summer 2022

The Commission on Dental Accreditation further directs a survey of past and current site visitors and current Review Committee members to determine barriers to service, perceptions and attitudes toward volunteering, and links of volunteerism to service, promotion and tenure, with further consideration by the Ad Hoc Committee on Volunteerism and Commission in Summer 2022.



The Commission on Dental Accreditation further directs that term limits for all Commission volunteers be retained, as dictated by current Commission policy.

The Commission on Dental Accreditation further directs that a single public member may serve as a member of more than one (1) Review Committee during their tenure as a Review Committee Public Member, effective immediately, with revision to the Commission's Evaluation and Operational Policies and Procedures as noted in **Appendix 34**.

**Consideration of a Request to Establish a Process of Accreditation for Advanced Dental Education Programs in Geriatric Dentistry:** The Commission considered the request from the Special Care Dentistry Association (SCDA), requesting that the Commission establish a process of accreditation for advanced dental education programs in geriatric dentistry (**Appendix 35**).

**Commission Action:** The Commission on Dental Accreditation directs the formation of an Ad Hoc Committee to consider the request that the Commission establish a process of accreditation for Advanced Dental Education Programs in Geriatric Dentistry, with a report to the Commission in Summer 2022.

**Report of the Standing Committee on International Accreditation:** There was no discussion on this report (**Appendix 36**).

**Commission Action:** This report is informational in nature and no action is required.

**Update on United States Department of Education (USDE)/Update on Higher Education Accreditation:** Dr. Sherin Tooks, Director, CODA provided a brief update on the Commission's re-recognition petition with the United States Department of Education.

**Survey of Meeting:** Commissioners were reminded to complete the electronic post-meeting survey following the meeting. The survey is important for determining whether the Commission is achieving its goals for the year and how the virtual meeting technology performed for this meeting.

**New Business:** *Changing Landscape of Healthcare Delivery Centers that May Sponsor Advanced Dental Education Programs and the Increased Interest in Creation and Potential Accreditation of Combined Advanced Dental Education Programs in Two Disciplines:* The Commission on Dental Accreditation considered a new business item related to advanced dental education programs, including: 1) the changing landscape of healthcare delivery centers that may sponsor advanced dental education programs, and 2) increased interest in creation of combined educational programs in two (2) advanced disciplines.

First, the Commission noted that the Health Resources and Services Administration (HRSA) provides federal grants to dental education programs and, through CODA's United States Department of Education (USDE) recognition, dental education programs accredited by CODA



have access to these federal funds. The Commission learned that the academic environment in which dental education programs may be developed could include facilities that may not directly be classified as a “hospital” or “educational institution,” which are the terms used in nine (9) of the 12 advanced dental education Accreditation Standards. Conversely, five (5) of the 12 advanced dental education Accreditation Standards state that a sponsor of a dental education program may be an “educational institution, hospital, or health care organization.” As new institutional sponsorship models for dental education programs develop, it was noted that the Commission may want to revisit the advanced dental education Standards to ensure they address the changing landscape of healthcare delivery centers that could sponsor advanced dental education programs.

Second, the Commission noted that there appeared to be an increase in interest to create combined advanced dental education programs in two (2) discipline areas. These programs can be independently accredited with advanced standing and/or part-time tracks for a co-enrolled student/resident as they progress from one (1) program to another. Alternately, an institution may contact the Commission office and request submission of an application for a combined (two discipline) program. Currently the Commission accredits only one (1) combined program in Orthodontics and Dentofacial Orthopedics/Periodontics. The Commission may wish to study the process by which it would create an application for an institution that requests accreditation of a combined program. For example, should the Commission’s staff create a combined Standards and related documents upon request for any two (2) combined disciplines, or should CODA first consider the topic and request for Standards and documents to create a combined discipline program to determine whether it will dedicate resources to permit accreditation of a particular combined discipline program.

The Commission considered both of these topics, and a motion was made to form an Ad Hoc Committee of all 14 advanced dental education Commissioners to study the two issues presented, with input from each Review Committee in Summer 2022, and a report to CODA at the Summer 2022 meeting. A friendly amendment was made to remove the reference to the 14 advanced education disciplines to allow staff and CODA’s chair to determine who should be involved in the Ad Hoc Committee. It was believed by some that the first step in reviewing the dual-program issue would be to first survey programs to determine if there is an interest in dual-program training. Following discussion, the Commission directed formation of an Ad Hoc Committee to further consider these matters.

**Commission Action:** The Commission on Dental Accreditation directs the formation of an Ad Hoc Committee to consider the changing landscape of healthcare delivery centers that may sponsor advanced dental education programs and the increased interest in creation and potential accreditation of combined advanced dental education programs in two (2) discipline areas, with a report to the Commission in Summer 2022.
