The meeting of the Review Committee on Predoctoral Dental Education (PREDOC RC) was held on June 30, 2022 via a virtual meeting. The PREDOC RC report is found in **Appendix 6**.

Informational Report on Frequency of Citings of Accreditation Standards for Dental Education Programs: There was no discussion on this report.

Commission Action: This report is informational in nature and no action was taken.

Informational Report on Frequency of Citings of Accreditation Standards for Dental Therapy Education Programs: There was no discussion on this report.

Commission Action: This report is informational in nature and no action was taken.

Report of the Ad Hoc Committee to Review Accreditation Standards for Dental and Dental Therapy Education Programs: The Commission considered the PREDOC RC report. An amendment was presented to include two (2) practitioner Commissioners on the Ad Hoc Committee, and that the American Dental Education Association (ADEA) submit eight (8) nominees, and the Commission select four (4) ADEA members to serve on the Committee. The Commission discussed whether both Commissioner practitioners should be general dentists or should advanced dental practitioners also be included on the Committee. It was noted that general dentists should be included to demonstrate that the workforce of general dentistry had input into the process; however, not both individuals need to be general dentists. Advanced dental practitioners could also bring an important perspective to the education of general dentists. The Commission discussed the importance of obtaining the practicing community's perspective, as is the ability for the Commission to have the flexibility to select all members of the Ad Hoc Committee to ensure a varied group of individuals are involved in the Standards review process. After discussion, the Commission approved an amended recommendation to include the addition of two (2) Commissioners who are dental practitioners, one of whom is a general dentist on the Ad Hoc Committee. The Commission also amended the recommendation of the PREDOC RC to request that ADEA submit the names of eight (8) ADEA members who are predoctoral dental educators, from which CODA will select four (4) ADEA representatives to serve on the CODA Ad Hoc Committee.

Commission Action: The Commission on Dental Accreditation directs the Chair to reconfigure the CODA Ad Hoc Committee to Review Accreditation Standards for Dental Education Programs to include four (4) CODA Predoctoral Dental Education Review Committee members [three (3) predoctoral educators, and the incoming Review Committee Chair], four (4) invited members from the American Dental Education Association, two (2) Commissioners who are dental practitioners, one of whom is a



general dentist, and the outgoing Predoctoral Dental Education Review Committee Chair who will serve as an ex-officio member of the Ad Hoc Committee for continuity.

The Commission further directs staff to invite the American Dental Education Association to submit the names of eight (8) ADEA members who are predoctoral dental educators, from which CODA will select four (4) ADEA representatives to serve on the CODA Ad Hoc Committee to Review Accreditation Standards for Dental Education Programs.

The Commission further directs that the Ad Hoc Committee to Review Accreditation Standards for Dental Education Programs focus its work primarily on the review and development of potential revisions to the Accreditation Standards for Dental Education Programs, culminating in a report to the Predoctoral Dental Education Review Committee and Commission on Dental Accreditation.

The Commission further directs that no changes be made at this time to the requirements related to institutional accreditation within the Accreditation Standards for Dental Education Programs and the Accreditation Standards for Dental Therapy Education Programs.

Consideration of Proposed Revision of Standard 1-1 of the Accreditation Standards for Advanced Dental Education Programs in Advanced Education in General Dentistry and General Practice Residency Related to Institutional Accreditation: The Commission considered the PGD RC report related to Standard 1-1 of the Advanced Education in General Dentistry (AEGD) and Accreditation Standards for Advanced Dental Education Programs in General Practice Residency (GPR).

Commission Action: The Commission on Dental Accreditation directs further consideration of the proposed revision to Standard 1-1 of the Accreditation Standards for Advanced Dental Education Programs in Advanced Education in General Dentistry (AEGD) and Accreditation Standards for Advanced Dental Education Programs in General Practice Residency (GPR) be postponed until the work of the Ad Hoc Committee to study the changing landscape of healthcare delivery centers that may sponsor advanced dental education programs is completed.

Consideration of the Policy on Enrollment Increases in Advanced Dental Education Programs: The Commission considered the PGD RC report related to Policy on Enrollment Increases in Advanced Education Programs as it applies to AEGD and GPR programs.

Commission Action: The Commission on Dental Accreditation directs the Standing Committee on Documentation and Policy Review be informed that the Postdoctoral General Dentistry Review Committee does not believe authorized enrollment is warranted for the disciplines of advanced education in general dentistry and general practice residency. The Commission further directs staff to work informally with the Postdoctoral General Dentistry Review Committee to identify and implement, if applicable, additional ways to assist in determining when and how to report enrollment increases for AEGD and GPR programs.

Report on the 2022 Validity and Reliability Study of the Accreditation Standards for Advanced Dental Education Programs in Advanced Education in General Dentistry and General Practice Residency: The Commission considered the PGD RC report related to the validity and reliability study results of the Accreditation Standards for Advanced Dental Education Programs in Advanced Education in General Dentistry (AEGD) and the Accreditation Standards for Advanced Dental Education Programs in General Practice Residency (GPR).

Commission Action: The Commission on Dental Accreditation directs adoption and immediate implementation of the Accreditation Standards for Advanced Education Programs in General Dentistry (Appendix 7) and Advanced Education Programs in General Practice Residency (Appendix 7) and related documents, as a result of the Validity and Reliability Study.

The meeting of the Review Committee on Dental Assisting Education (DA RC) was held on July 14-15, 2022 via a virtual meeting. The DA RC report is found in **Appendix 8**.

Consideration of the Report of the Ad Hoc Committee to Review the Allied Dental Education Biosketch: The Commission considered the DA RC report related to revisions to the CODA Allied Biosketch.

Commission Action: The Commission on Dental Accreditation directs adoption and immediate implementation of the proposed revised Allied Biosketch (**Appendix 9**) and inclusion in all applicable Commission documents including the Dental Assisting Self-Study Guide.

Consideration of Accreditation Standards Related to Institutional Accreditation: The Commission considered the DA RC's report related to institutional accreditation in the Dental Assisting Education Standard 1-5.

Commission Action: The Commission on Dental Accreditation directs adoption and immediate implementation of the proposed revisions, **Appendix 8**, to Standard 1-5 of the Accreditation Standards for Dental Assisting Education Programs and all related documents.

Consideration of Proposed Revisions to the Accreditation Standards for Allied Dental Education Programs in Dental Assisting: The Commission considered the DA RC's report related to revisions to Dental Assisting Education Standards 2-1 (admissions), 3-8 (faculty to student ratios) and 3-4 (program administrator qualifications) proposed by 15 state dental associations and the ADA's Council on Dental Education and Licensure (CDEL). A Commission member asked whether the Review Committee considered the number of programs that are closing and difficulty in developing new programs. The Commission learned that the Review Committee considered these matters under New Business, and also noted that many states do not require graduation from a CODA-accredited program to practice as a dental assistant.

Commission Action: The Commission on Dental Accreditation directs that there be no revision to Standard 2-1 (admissions), Standard 3-8 (faculty to student ratios), and Standard 3-4 (program administrator qualifications) of the Accreditation Standards for Dental Assisting Education Programs.



New Business: Discussion Related to Decline in CODA-Accredited Dental Assisting Programs: The Commission considered the DA RC's new business related to tracking programs' reason for discontinuance of accreditation and/or program closure. The Review Committee noted that the decline in CODA-accredited dental assisting programs may be a result of lack of licensure requirements to include graduation from a CODA-accredited program and recommended that CODA obtain information from programs to understand why a program may close or voluntarily discontinue accreditation.

Commission Action: The Commission on Dental Accreditation directs the Standing Committee on Documentation and Policy Reviews to review and revise, as needed, the policy and procedure for reporting program closure/discontinuance/teach-out reports to provide the Commission with feedback as to why programs discontinue CODA-accreditation.

Commission Action: The Commission on Dental Accreditation directs adoption and immediate implementation of the proposed revised Allied Biosketch (**Appendix 11**) and inclusion in all applicable Commission documents including the Dental Hygiene Self-Study Guide.



Consideration of Accreditation Standards Related to Institutional Accreditation: The Commission considered the DH RC's report related to institutional accreditation in the Dental Hygiene Education Standard 1-6.

Commission Action: The Commission on Dental Accreditation directs adoption and immediate implementation of the proposed revisions, noted above, to Standard 1-6 of the Accreditation Standards for Dental Hygiene Education Programs and all related documents.

Consideration of Proposed Revisions to Accreditation Standards for Dental Hygiene Education Programs: The Commission considered the DH RC's report related to proposed revisions to Dental Hygiene Education Accreditation Standards 3-5 (faculty to student ratios) and Standard 3-6 (faculty qualifications) and 2-14 (periodontal status of patients).

Commission Action: The Commission on Dental Accreditation directs there be no revision to Standard 3-5 (faculty to student ratios) and Standard 3-6 (faculty qualifications) of the Accreditation Standards for Dental Hygiene Education Programs.

Report of the Standing Committee on Nominations: The Commission considered the report of the Standing Committee on Nominations found in **Appendix 25**, including the nominations of qualified consumer/public members for the Review Committees, and nominations to vacant positions on Review Committees.

The Commission considered nominations submitted by the Standing Committee to fill open positions on the Review Committee and public members of the Board of Commissioners.

New Business: Dental Laboratory Owner Nominated by the National Association of Dental Laboratories: The Commission discussed the difficulty in obtaining a sufficient number of qualified nominations (i.e., a dental laboratory owner) from the National Association of Dental Laboratories (NADL). The Commission considered whether a Certified Dental Technician should be nominated by the NADL rather than a dental laboratory owner. It was also noted that some owners may not have the technical knowledge to serve in this role, however, managers may be better suited to serve in this role. Following discussion, the Commission revised the criteria for the role in Dental Laboratory Technology Education Review Committee nominated by the National Association of Dental Laboratories (NADL), as noted below.

Commission Action: The Commission on Dental Accreditation adopted with immediate implementation a revision to its Review Committee Composition and Criteria for Nominations for the role formerly noted as “1 dental laboratory owner nominated by the National Association of Dental Laboratories” to the new role noted as “**1 Certified Dental Technician who manages and/or supervises dental laboratory technicians, nominated by the National Association of Dental Laboratories**” for the Dental Laboratory Technology Review Committee.

The Commission further directs staff to update all applicable Commission documents related to the revised criteria for the Dental Laboratory Technology Review Committee role.

New Business: Public Member Nominations: The Commission discussed the ongoing need for public member nominations, noting that some public member nominees have either current or recent experience on other dental organizations and/or boards. The individual may otherwise be considered a member of the public; however, it was believed that either a current or immediate past relationship with another dental organization and/or board does not fulfill the spirit of the requirement for public members as required by the Commission and in accordance with regulations of the United States Department of Education. The Commission believed that having served in a public member capacity within the past three (3) years on another dental organization



and/or board should disqualify the individual from service with the Commission until such time that their prior public member service has been terminated more than three (3) years.

The Commission adopted the following addition to the criteria for “Public/Consumer Nominees” for the Review Committee and Commission (addition is underlined):

A commitment to bring the public/consumer perspective to Review Committee deliberations. The nominee should not have any current or past (within the past three years) formal or informal connection to the profession of dentistry; also, the nominee should have an interest in, or knowledge of, health-related and accreditation issues. In order to serve, the nominee must not be a:

- a. Dentist or member of an allied dental discipline;
- b. Member of a predoctoral, advanced, or allied dental education program faculty;
- c. Employee, member of the governing board, owner, or shareholder of, or independent consultant to, a predoctoral, advanced, or allied dental education program that is accredited by the Commission on Dental Accreditation, has applied for initial accreditation or is not-accredited;
- d. Member or employee of any professional/trade association, licensing/regulatory agency or membership organization related to, affiliated with or associated with the Commission, dental education or dentistry; and
- e. Spouse/Partner, parent, child or sibling of an individual identified above (a through d).

Commission Action: The Commission on Dental Accreditation adopts with immediate implementation a revision (noted above) to its “Public/Consumer Nominees” criteria for the Review Committees and Commission.

The Commission further directs staff to update all applicable Commission documents related to the revised criteria for the Public/Consumer Nominees role.

New Business: Streamlining and Simplifying the Nomination Scoring Process: The Commission noted the Standing Committees recommendations to review and streamline the nomination review process for vacancies on the Commission and its Review Committees.

Commission Action: The Commission on Dental Accreditation directs the Nominations Committee to review its scoring process to better align with the needs of the Committee’s review.

Report of the Ad Hoc to Consider Advanced Dental Education Delivery Models and Combined Programs: The Commission considered the report from the Ad Hoc Committee (Appendix 26). The Commission discussed why a process to permit combined programs was not recommended. The Commission noted the infrequency of this type of request, and the ability of programs to establish part-time tracks and advanced standing admission to allow an individual to complete two (2) advanced dental education programs. Therefore, there is no need to create a combined discipline accreditation process on an ad hoc basis.



Commission Action: The Commission on Dental Accreditation directs that it not establish a process for accreditation of combined advanced dental education programs in two (2) discipline areas.

The Commission further directs that formal review of any future requests for the development of Standards and related documents for accreditation of a new combined program in two (2) disciplines, in accordance with Commission policies and procedures, to determine whether development of an accreditation process for a combined (two-discipline) program is warranted.

The Commission further directs the Ad Hoc Committee to Consider Advanced Dental Education Delivery Models and Combined Programs to continue its review of the changing landscape of healthcare delivery centers that may sponsor advanced dental education programs, with a report to the Commission in Winter 2023.

Report of the Ad Hoc Committee to Consider a Request to Establish a Process of Accreditation for Advanced Dental Education Programs in Geriatric Dentistry: The Commission considered the report from the Ad Hoc Committee (**Appendix 27**). The Commission discussed the report and whether accreditation of programs may result in an increase in practitioners to treat geriatric patients. The Commission noted the Ad Hoc Committee's conclusion that other programs, such as second year programs in advanced education in general dentistry and general practice residency programs, could focus on this population.

Commission Action: The Commission on Dental Accreditation directs that the Commission not establish a process of accreditation for advanced dental education programs in geriatric dentistry at this time.

The Commission further directs that it formally communicate its decision not to establish a process of accreditation for advanced dental education programs in geriatric dentistry to the Special Care Dentistry Association.

Consideration of a Request to Establish a Process of Accreditation for Advanced Dental Education Programs in Operative Dentistry, Cariology and Biomaterials: The Commission considered the request from the Academy of Operative Dentistry (AOD) that the Commission establish a process of accreditation for advanced dental education programs in Operative Dentistry, Cariology and Biomaterials (**Appendix 28**). The Commission began its discussion noting that an Ad Hoc Committee should consider the application, as has been the Commission's process with past requests. The Commission also noted, however, that there was not a comparison in the application of the potential overlap with prosthodontics. Additionally, it was noted that advanced education in general dentistry may cover the content in operative, cariology and biomaterials. Conversely, there were comments indicating that some aspects of the discipline may be unique related to dental caries and biomaterials. Others believed that



predoctoral dental education and postdoctoral general dentistry may already address these areas. The Commission was reminded that it had reviewed a previous request for this area of dentistry. Following discussion, the Commission determined that an Ad Hoc Committee should be established to consider the request that the Commission establish a process of accreditation for Advanced Dental Education Programs in Operative Dentistry, Cariology and Biomaterials.

Commission Action: The Commission on Dental Accreditation directs the formation of an Ad Hoc Committee to consider the request that the Commission establish a process of accreditation for Advanced Dental Education Programs in Operative Dentistry, Cariology and Biomaterials, with a report to the Commission in Winter 2023.

Report on Appointment of Commissioners and Appeal Board Members: The Commission reviewed information on the Commissioners and Appeal Board Members whose terms will end at the American Dental Association (ADA) 2022 Meeting and their replacements whose terms will begin at the ADA Meeting. The Commission also reviewed information on the 2023 Commissioner Trainees whose terms will begin in 2024 (**Appendix 29**).

Commission Action: This report is informational in nature and no action was taken.

Election of Chair and Vice Chair of the Commission: By acclamation, the Commission elected Dr. Sanjay Mallya as chair of the Commission and Dr. Maxine Feinberg as vice-chair of the Commission for 2022-2023.

Report of the Commission on Dental Accreditation of Canada (CDAC): Dr. Debora Matthews, Chair of the Commission on Dental Accreditation of Canada (CDAC) provided an update on the CDAC activities as presented in the CDAC's report to the Commission.

Commission Action: This report is informational in nature and no action was taken.

Update on United States Department of Education (USDE)/Update on Higher Education Accreditation: Dr. Sherin Tooks, Director, CODA provided a brief update on CODA's re-recognition petition with the United States Department of Education.
