Dr. Sherin Tooks, EdD, MS, director, Commission on Dental Accreditation

Dr. Sherin Tooks has been with the Commission on Dental Accreditation (CODA) since January 2002 and was appointed Director of CODA in November 2012. Prior to her appointment as Director, Dr. Tooks held the position of Manager, Advanced Dental Education within the Commission. Dr. Tooks oversees the operations of the Commission and serves as staff secretary of the Standing Committee on Finance, the Standing Committee on Quality Assurance and Strategic Planning, the Standing Committee on Nominations, and the Standing Committee on International Accreditation. Dr. Tooks has guided the Commission through important initiatives, including strategic planning, re-recognition by the United States Department of Education and, most recently, CODA's development of an electronic accreditation platform. Dr. Tooks holds a Master of Science degree in dental hygiene education, from the University of Missouri-Kansas City School of Dentistry and a Doctor of Education degree, with an emphasis in educational leadership, from the University of Phoenix.
